**JOB DESCRIPTION:** Under direction of a managerial officer in the Department of Corrections, supervises the institutional business and fiscal activities of a designated region which may consist of one or more institutional business offices, and storerooms/commissaries. The activities may include preparation of operating budgets and the development of budget expenditure projections; procurement and consultation with vendors or contractors; authorization of payments and transfer of monies from accounts; monitoring of internal audit systems, storage, and distribution of materials, supplies, and equipment. May oversee other institutional units as needed; does other related duties as required.

## REQUIREMENTS

**NOTE:** Applicants must meet one of the following or a combination of both experience and education. Thirty (30) semester-hour credits are equal to one (1) year of relevant experience.

Ten (10) years of professional financial experience in a medical, educational, correctional, or training facility or other business operation with responsibility for preparation of financial statements and reports, review of financial records, oversight of the development of internal accounting control procedures, and assisting in the development and analysis of an office, unit, agency, or organizational budget, four (4) years of which shall have been in a supervisory capacity.

## OR

Possession of a bachelor's degree from an accredited college or university; and six (6) years of the above-mentioned professional experience, four (4) years of which shall have been in a supervisory capacity.

### OR

Possession of a master's degree in Business, Public Administration, Accounting, Finance, or Economics from an accredited college or university; and five (5) years of the above-mentioned professional experience, four (4) years of which shall have been in a supervisory capacity.
